The Attendance Monitoring system is run by The University of Huddersfield and is currently being used staff of the University of Huddersfield.

Users of the system should be able to:

- Navigate most of the website using just a keyboard (or touch screen if on a mobile device)
- You can magnify the text to 400% without it going off the screen
- Listen to most of the website using a screen reader (including tools built into Windows 7/8/10 and Chrome/Internet Explorer – Additional Chrome or IE extensions may need to be downloaded).
- Use the Website on a Mobile Device (phone or tablet)

We've also made the website text as simple as possible to understand.

How accessible this website is

We know some parts of this website are not fully accessible:

1. you cannot modify the line height or spacing of text
2. you cannot skip to the main content when using a screen reader
3. Although the website can be used on a mobile phone, it is not quite optimised for the small screen. Works fine on a tablet.
